This is used to calculate the total valuation of the project. Impact fees are not assessed on these types of permits. <p style="text-align: center;"><b><u>Determining Permit Fee</u></b></p> <p>Herriman City figures the permit fee from getting a total valuation of a project, then assessing the city's pre-determined fees based off of this valuation. The steps to the right will help get to this permit fee, which will be inserted into the fee schedule in the upper right corner box. ## EXAMPLE

### 700 sq.ft. Detached Garage

#### Figuring A Permit Fee

First figure the project valuation:

1<sup>st</sup> Step: Total sq. ft. of finished area- 700 .

2<sup>nd</sup> Step: Times 1<sup>st</sup> step by \$36.00 x 700 .

3<sup>rd</sup> Step: After 1<sup>st</sup> & 2<sup>nd</sup> step this is

\* Your total valuation = \$25,200 rounded to nearest thousand is  
\$25,000.

Now you must figure out your permit fee from the valuation just figured:

#### Herriman Ordinance for permit fees

PER VALUATION:

\$69.25 for the first \$2,000 of valuation cost and \$14 for each additional \$1,000 after the first \$2,000 of the valuation cost.

**Total valuation is \$25,000**

Using Herriman Ordinance for permit fees, you get the permit fee as follows:

**First \$2,000 = \$69.25**

**\$14 for each additional \$1,000 after the first \$2,000**

**So times \$14 by 23 additional thousands (\$25,000-\$2,000 = \$23,000) = \$322**

**So the permit fee is \$69.25 + \$322**

**=\$391.25**

Enter this number into the Permit Fee line on the other side to figure the total Permit Cost
