SUBMITTAL REQUIREMENTS

- Application
- Site plan providing all setbacks measurements for ground mounted signs.
- Accurately dimensioned scaled drawings showing height, color, square foot dimensions, sign composition, type of illumination, and how the sign will appear from the street.
- Details of sign construction including electrical plan if applicable.
- Signs are not permitted on City property.

Temporary Signs (may not be permitted)

• Temporary signs are allowed for a maximum of twenty-one (21) days at any one time, with a minimum thirty day separation between displays, and not more than four times during a calendar year.

Monument Signs

- Site plan showing relationship of the sign to buildings, property lines, setback from streets and public rights-of-way, intersection, easements and driveways.
- Number of acres for the entire site.
- Landscaping plan indicating square footage of the landscaped area, plant types and placement in relation to the sign, and layout of the landscaped area.
- Elevations Stone required on one side and 18 inch stone base to match building (**If design does not meet these standards**, a Conditional Use application is required Contact the Planning Department for more information).
- Receive Architectural Review Committee approval, if applicable.
- Height and size requirements found in the Herriman City Ordinance, section 10-27-7.

Construction Signs

- Allowed during the construction of a subdivision. Signs must be removed within 30 days after the last lot is sold
- Signs must be on private property and must be 300 feet from any other construction signs.
- Height and size allowances dependent on the number of builders combining on one sign. See Herriman City Ordinance 10-27-7 for specific requirements.

Wall, Promotional, & Ground Sign \$100 per application

Temporary Sign \$50 each
Monument Sign \$100 each
Construction Sign \$50 each
