A Ray of Hope

So much has changed this spring. Each day brings new information regarding the challenges we face dealing with COVID-19.

Governor Herbert announced an order to change our public health phase from Red to Orange, effective May 1st. Salt Lake County Mayor Jenny Wilson signed a related public health order to allow for a phased re-opening of businesses that have been closed. Both orders align with the information provided in the Utah Leads Together 2.0 plan. The Orange Phase is one step below the red phase and notes we are still in a moderate risk period. **It is important for the community to remember that this is not a return to life as we knew it. Social distancing and wearing face coverings in public spaces are still a necessity.** Masks not only help prevent you from catching the virus, but minimize the possibility that you may spread it to others without knowing you are a carrier. When in large groups or shopping, wear a mask for safety of yourself and those around you.

City parks and trails are open to provide a place to go for exercise and enjoyment, but the social distancing guidelines apply. Playgrounds and Blackridge Reservoir beach and water areas remain closed, but our sport courts are now open. No team sports or close contact recreation are allowed at this time.

As we look towards the future, we are focused on getting back to business, so to speak. So many have been out of work due to the virus, creating hardships for many in our community. This Orange Phase allows businesses to reopen as long as they follow strict guidelines to keep the public healthy and safe. We urge businesses to put public health first by putting precautions in place for employees and patrons. We understand that business drives our economy and we want to ensure that safe practices are being followed to reduce the potential of moving back into the Red Phase. Herriman

ORDINANCE 2020-09

An ordinance **adding a section** to the code **prohibiting the discharging of firearms** within City Limits with some exceptions.

ORDINANCE 2020-10

An ordinance **approving an amendment** to the Master Development Agreement for the **Rosecrest Development**.

ORDINANCE 2020-11

An ordinance **approving the first amendment** to the Master Development Agreement for **Creek Ridge** with respect to property located at or near 6600 W 11800 S to reduce the maximum residential units permitted by the Master Development Agreement.

ORDINANCE 2020-12

An ordinance **adopting an amendment to the Herriman City General Plan** for property located at approximately 14011 South Sentinel Ridge Boulevard.

ORDINANCE 2020-13

An ordinance **approving a zoning map amendment to rezone 77 acres from A-1 to R-2-10** for property located at 14011 South Sentinel Ridge Boulevard.

ORDINANCE 2020-14

An ordinance **superimposing the Planned Development Overlay Zone** to certain property at approximately 14011 South Sentinel Ridge Boulevard.

ORDINANCE 2020-15

An ordinance **approving a Master Development Agreement with Edge Homes** for approximately 105 acres of land located at or near 14011 South Sentinel Ridge Boulevard.



It is always a challenge to change jobs. It's particularly tricky in Computer and Information Systems since everyone you work with will have unique hardware and software. In January, Herriman City was lucky enough to welcome Scott Munson to the team after he spent an impressive 18 years with the Utah Department of Health. He dove headfirst into our systems and quickly absorbed the various methods and means each department requires.

Just when he was getting a feel for our processes, the unprecedented restrictions of COVID-19 began. Though a pandemic impacts a City much differently than it would the Department of Health, Scott was nevertheless thrust into a complicated, unique situation. Managing the challenge while being contacted by many former co-workers accustomed to relying on his expertise, Scott has responded incredibly throughout this situation. He carries a heavy load to make sure employees can work from home, that the required communication is available, and the safety and security of remote connections are managed. Just days after the onset of the pandemic, Scott and his team had twenty laptops installed to replace tablets in police vehicles. The tablets were immediately converted to allow several employees to work from home, maintaining the City's ability to provide service to the community. He quickly had programs in place to allow for virtual meetings and community participation.

Scott has proven to be a critical member of the Herriman team and is demonstrating his ability to stay calm and cool in a serious situation. He is a natural leader and has increased the skill and professionalism of the IT staff through his communication and support. Adding an employee of this caliber has helped the City adapt to the challenges of the coronavirus as smoothly as possible.

Weeding Out the Cracks

Herriman City's Trails Coordinator and others have been working diligently to fill large cracks in our urban trail system with a mastic crack fill. This product helps fill the hazardous gaps and prevents moisture from penetrating the sub-grade below the pathways. This process helps prepare for a seal coat that will be applied later this year.

City staff has also been aggressively spraying weeds along the trail system and open space as weather permits. The warm weather accelerates weed growth, so the more crews can spray early, the less they will need to mow and trim down in the future.
