- To strictly comply with all rules, regulations, and policies now and hereafter adopted by HCMWD. A current copy of all such rules, regulations, and policies may be obtained upon request.
- To permit HCMWD, its agents, or employees, to enter the service location at all reasonable times for inspection and for other reasonable purposes regarding water services.
- To make water meters and related equipment readily accessible to HCMWD, its agents, or employees and remove all barriers or obstructions (including restraint of animals) that restrict access to water meters and related equipment.
- To permit HCMWD, its agents, or employees to take all necessary measures to gain access to water meter and related equipment.
- To pay an interest charge in the amount of 1.5% per month on all delinquent balances.
- That if the Applicant's account (which may include a law enforcement service fee or park fee) become delinquent for more than 30 days, water service may be discontinued.
- That HCMWD may, without notice, shut off, limit, and/or curtail water services due to water scarcity, to repair or maintain HCMWD's water system, or in the event of an emergency.
- To notify HCMWD one week in advance of termination.
- All parts of the service connection from the downstream side of the meter to the main line are the property of HCMWD.
- TO PAY ALL COSTS, INCLUDING REASONABLE ATTORNEY'S FEES, INCURRED BY HERRIMAN CITY MUNICIPAL WATER DEPARTMENT THROUGH IT'S EFFORTS TO COLLECT ANY DELINQUENT BALANCE AND/OR TO ENFORCE THIS AGREEMENT.
- That this application will be effective upon written acceptance by HCMWD.
