Highlights of Newly Approved Utility Billing Ordinance

The Herriman City Council has adopted an updated Utility Billing Ordinance that clarifies the billing process and defines billing and due dates. This ordinance reiterates that the City Treasurer is responsible for all billing decisions. In the past, billing adjustments had been performed in other departments creating confusion and discrepancies when handling customer payments. In our efforts to mitigate such issues, the process has become more streamlined.

One notable change in the Ordinance states the requirement of a \$200 deposit for all new residential and commercial accounts. This deposit is refundable after 24 months of on time payments. A customer can apply for an exemption from the deposit if they can prove 24 months of payments with less than two delinquencies with their previous water company. Other deposits covered in the Ordinance include a \$100 per unit deposit (\$1,000 maximum) for multi-family accounts, and a \$1,000 for construction hydrant meters.

The billing cycle will be more consistent under the updated ordinance. Utility meters will be read on the first business day following the end of the month. The Utility bills will be sent out on the 10th of the month with a due date of the 28th. A delinquency charge is assessed two days after the due date in the amount of 1.5% of the delinquent balance. If an account had a delinquency of thirty (30) or more days, a delinquent notice will be sent and shut off will occur seven (7) days after the notice.

Once an account has been shut off, an un-waivable reconnection fee is assessed in order to have the water turned back on. Accounts that have been shut off must be paid current using cash, debit/credit card, or other form of certified payment. Personal checks will not be accepted. Deferred payment plans are not available as payments must be made within the terms of the account.

Each residence is assessed a park fee of \$5 per month. The park fee is included on the monthly utility bill and is used to assist with the costs of maintaining our parks and green space. Multi-family housing will be billed the park fee on the same basis as the water bill. If the water is billed on a master meter, all park fees will be billed that way as well. The City does not bill an association for water and then send individual bills to homeowners for a park fee. It is the responsibility of the association receiving the water bill to distribute those fees.

If you are looking for convenience in paying your utility account, the City has several options. Customers can sign up for e-bill to receive their bills electronically. They can also sign up for Auto Pay directly through the City, or through Xpress Billpay. If you have held a current utility account for twelve (12) months, you have the option to sign up for equal pay. This option calculates your average usage for one year's time and divides it out into equal payments over twelve months. The amount will be recalculated annually in order to adjust for changes in usage.

New Utility Billing Ordinance



- ✓ \$200 deposit required for new residential and commercial accounts (refundable after 24 months)
- ✓ Account can be exempted IF:
 - Customer has already met 24 month test
 - Proven 24 months with less than 2 delinquencies with other water company
- ✓ Utility meters read on first business day of the month
- ✓ Utility bills sent on the 10th of each month
- ✓ Due date is the 28th of each month
- ✓ Delinquency charge after 2nd day past due date at 1.5%
- ✓ Delinquent notices sent 30 days after due date; shut offs will occur 7 days after notices
- ✓ Unwaivable reconnect fee is assessed on all shutoff accounts



Something's Fishy at The Cove @ Herriman Springs

One of the things we all love as residents of Herriman City is all the wonderful parks that we have. The Cove at Herriman Springs is one of them with a wide variety of uses. There are picnic areas, a play set for the little guys, a volleyball court, biking and walking trails, fishing, and wildlife. The Cove at Herriman Springs is special because it is one of the Utah DWR's community fish ponds.



The DWR helps us as a parks department to stock and maintain our fishery at The Cove. There is a lot that goes into maintaining a fishery and we all want to be wise stewards of the things that are entrusted to us. The rules at The Cove, such as a limit of 2 fish per person and to not feed the ducks and geese, are there to help make it a more enjoyable park for everyone.

The main purpose for the pond at The Cove is a fishery, not a duck pond. The reason this is so important is that a ducks main diet is fish. All of the ducks and geese at The Cove do not help us maintain a good fish habitat. We are not opposed to the wild ducks that are there, but that being said, we need to all work together to make sure that it is not a place where they want to make their permanent residence. Wild ducks are migratory birds and should come and go throughout the different seasons. One of the things that we can do to make The Cove a less desirable place for migratory ducks to set up permanent residence is by not feeding them. Not only does feeding the ducks encourage them to stay, but it also takes away their natural instinct to hunt for their food. This is neither helpful nor healthy for wild migratory ducks. Domesticated ducks have become an issue at The Cove in recent years and are permanent residents there. Domesticated ducks get to The Cove through people releasing them there; once they are there they will stay and reproduce year after year. The Cove is NOT an acceptable location to release ducks. Please help us all do our part in keeping The Cove what it was meant to be by not feeding the ducks or by releasing unwanted ducks there.

The Cove is a great place for park goers of all ages with a wide variety of amenities and activities. 
Herriman City Parks are the Best



2017 Spring Cleanup Schedule



New Schools on the Horizon

Herriman City has quickly become an attractive place for young families. As our neighborhoods grow, the need for school capacity increases. Our younger population continues to expand and with that comes a need for additional schools in order to provide education for those developing, young minds.

In efforts to alleviate some of the crowding in current schools, as well as accommodate new neighborhood developments, Jordan School District has selected locations and released their 5-year Building Construction Plan which includes 4 new schools in Herriman City.

A new elementary school is currently being built at 5692 W. American Park Drive in Herriman. This school boasts natural lighting and bright colors to stimulate student learning. Doree Strauss was announced as principal of the new school. The South East end of the valley has plans for a new elementary, middle school and high school to be located just north of the new Parkhouse @ Rosecrest subdivision. The approximate address is 14199 S. 4800 W. (Autumn Crest Rd.). These schools were made possible as part of the bond that was recently passed.

In addition to these public schools, the City has also welcomed Athlos Academy, a new charter school located at 12309 Mustang Trail Way. The RSL Academy is scheduled to open in the fall and is located at the new soccer complex. It will focus on the S.T.E.M. program. Lastly, the Elizabeth Academy has expressed interest in locating within Herriman. They are looking at a parcel that is located at the south end of the City as well. You should see these schools begin to pop out of the ground as early as mid-2017. Keep an eye out for updated safe walking routes due to boundary changes and new schools.
